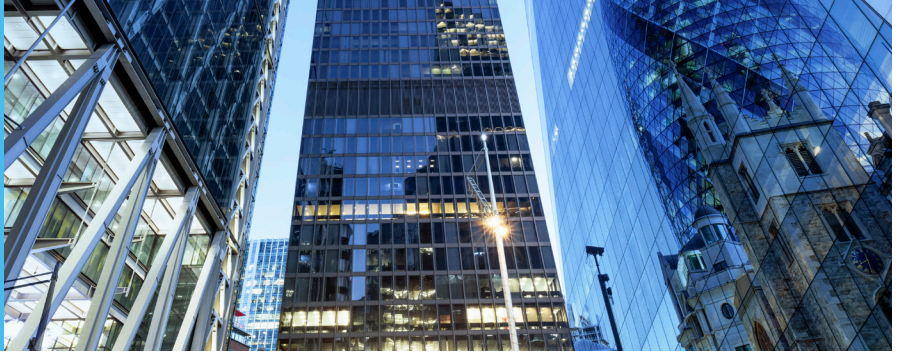

How Will Work *Work* Now? COVID-19, the 6-foot office and heightened consumer hygiene/sanitation concerns.

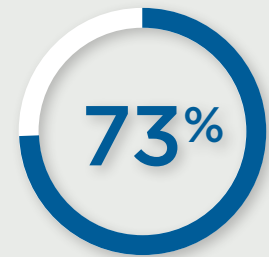
Job #1: Implementing safe social distancing and proper hygiene practices building-wide is imperative to reassuring anxious employees returning to work.

The “new normal”, by the numbers:

- **73% of employees** are concerned about illness spreading in their office.
- **47% of employees are concerned** that their office building will not take adequate steps to ensure a hygienic work environment.¹
- **Remote working will likely increase**, which may reduce occupancy and impact PM's and BSC's bottom line.
- **When someone brings a virus to the office**, ≈50% of commonly touched surfaces become infected by noon, according to University of Arizona.²

BUSINESS IMPACT

Lost Productivity, Tenants and Revenue:

What's at stake if you don't amp up office sanitizing/disinfecting?

For Occupants:

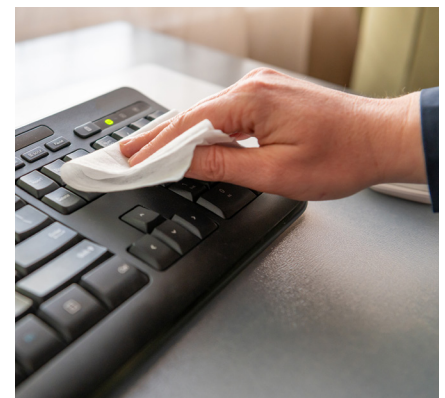
- For a 2000-person office, that amounts to ~\$1MM. If you can help keep your employees productive and well, can you really put a price on an investment in enhanced cleaning, sanitation and disinfecting?³

For Property Managers:

- **Loss in Rent:** national average is ~\$30/sq.ft. (Class A buildings) and ~\$20/sq.ft.⁴ (Class B buildings)
- **Marketing cost:** can amount to almost ~\$1/sq.ft.⁵
- **Leasing commissions:** brokerage fees for a new 7-year lease are 6%, and are set at 4% for renewal.⁵
- **Tenant improvement allowances:** ranges from \$30-50+/sq.ft., depending on type of office build-out.⁵
- **Admin. & cleaning:** rental contract processing and upkeep/repair costs before property can be re-leased.

For Building Service Contractors:

- **Staff safety and absenteeism:** Since custodians are more exposed to germs, they have a higher likelihood of missing work.⁶
- **Cross-contamination risk:** High-contact surfaces and germ hotspots like restroom door handles, desks and exposed bulk cutlery in break rooms can elevate germ spread.⁶
